## Special Terms and Conditions Relating to Covid-19

## Tickets Terms and Conditions

All tickets sold online are the property of DXB Entertainments PJSC, the operator of Legoland Dubai, Motiongate Dubai, Riverland Dubai and Legoland Waterpark Dubai (each a “Park”). Entry and use of the Parks is subject to specific product terms and conditions, our general terms and conditions and those set out below:

1. Individuals entering the Park must hold a valid ticket which has been obtained from us, our website or an authorised third party.
2. The entrance ticket and other entitlements remain our property and are not for resale, are non-refundable, non-transferable, and may not be exchanged for commercial gain. Tickets and other entitlements are void if altered.
3. Non-dated tickets do not guarantee entry.
4. You will need to present the original ticket or a printed online voucher in order to gain entry into the Park.
5. The ticket is valid for the period stated on its face.
6. Your ticket is personal to you and may not be shared with others. The ticket is not valid for special events that require a separate admission charge. Tickets must be presented for re-entry to the Park on the same day.
7. Tickets should be retained and shown for inspection upon demand.



8. Children under the age of 13 must be accompanied by a responsible adult over the age of 18 and holding a valid ticket.
9. If tickets are bought on behalf of other guests (for example, group bookings), the buyer accepts these terms and conditions on behalf of every guest and shall ensure that these terms and conditions are complied with by each person in the group. If you are an adult supervising minor children in the Park then you accept these terms and conditions on behalf of those minors.
10. If you resell a ticket without our express consent, it will be void. By purchasing a ticket you agree that the tickets are for the personal use of you and your party only, and will not be resold or transferred.

## DUBAI PARKS AND RESORTS ANNUAL PASS TERMS AND CONDITIONS

These Dubai Parks and Resorts Annual Pass Terms and Conditions (“Terms and Conditions”) apply to Annual Passes relating to MOTIONGATE™ Dubai, LEGOLAND® Dubai, LEGOLAND® Water Park and Dubai Parks and Resorts (“DPR”) (each a “Theme Park” and collectively “Theme Parks”).

## GENERAL TERMS AND CONDITIONS

1. The Annual Pass entitles each Passholder (individually, a “**Passholder**”) to admission to the Theme Park for a period of one (1) year or three hundred and sixty-five days (365) from the date of purchase of the Annual Pass, subject to the available usage entitlements associated with the Annual Pass as set out in the Annual Pass Terms and Conditions by Product Type. A Passholder must abide by all rules and regulations applicable to DPR as published by DPR from time-to-time. DPR reserves the right to cancel, suspend, or revoke any Annual Pass or deny access

to the Theme Park or Theme Parks by any Passholder at any time, and for any reason.

2. Annual Passes are not valid for private events or events that require a separate admission, such private events or events that require a separate admission are subject to applicable Blackout Dates (as defined below) which will be published by DPR from time to time. Annual Passes do not guarantee admission to the Theme Parks, especially during high attendance periods or seasons.
3. A Passholder assumes all inherent risks associated with all rides and attractions and must obey all individual ride rules, safety signage, and instructions.
4. Upon entering a Theme Park it is deemed that you have given consent for DPR to film, record or use photography equipment, and for DPR to use any film, video, or reproduction of the image and/or voice of a Passholder for any purpose whatsoever without any objection by the Passholder or payment to the Passholder.
5. The Annual Pass entitles the Passholder to admission to the selected Theme Park and/or Theme Parks during scheduled operating hours for a period of twelve (12) months, from the date of sale. An Annual Pass will expire if it is not activated within one (1) year from the date of purchase, and upon expiration such expired Annual Pass may no longer be activated or cancelled. No refunds will be given for any Annual Pass that has not been activated. The Annual Pass may not be transferred, and the Annual Pass may not be redeemed for cash or be used for any other goods or services.
6. For those who purchase the Annual Pass online, they will receive an 'E-Ticket Receipt' which will be sent to their registered email address at the time of order confirmation and at the same time a payment receipt will be issued.
7. For those online purchasers, they are required to present a printed copy of the 'E-Ticket' upon their first visit to the Theme Park to ensure entrance to the relevant Theme Park or Theme Parks in order to redeem the Annual Pass and be issued with his/her own hard copy Annual Pass.
8. The hard copy Annual Pass will be a card featuring a photograph of the Passholder and each Passholder must comply with any specific photo requirements issued by DPR from time to time.

9. An Annual Pass can only be used by the named Passholder and when presented by the named Passholder displaying a photograph in compliance with DPR photo requirements, which in particular must be a true likeness of the Passholder. Photocopies or photographs of an Annual Pass will not be accepted.
10. Annual Passes are not transferable, refundable, or exchangeable and cannot be offered for resale and remain the property of DPR. Restrictions apply including, but not limited to, capacity constraints and other necessary closures. Additionally, Annual Passes may not be used for commercial purposes and are void if altered, defaced or misused. For the avoidance of doubt, a Passholder that seeks to share an Annual Pass with a third party regardless of reason, will be considered misuse of the Annual Pass and will result in the Annual Pass being revoked without compensation or refund to the Passholder.
11. The Passholder must present the Annual Pass upon entering the Theme Park or Theme Parks. Biometric prints are registered upon first use of an Annual Pass and are required upon each entry made using the Annual Pass. DPR reserves the right to validate the identity of the Passholder and may request the Passholder to present a valid United Arab Emirates Identification Card (“EID”) or other form of valid identification to use the Annual Pass and avail entry to the Theme Park or Theme Parks.
12. Any misuse of the Annual Pass or misconduct within the Theme Park(s) may result in confiscation, without compensation to the Passholder, and this shall be at the sole discretion of DPR.
13. If DPR believes that any Annual Pass has been purchased through other means not permitted by DPR, or have been illegally reproduced, such Annual Pass will be revoked without compensation.
14. DPR is not responsible for any lost or stolen property whilst guests are on site at any of the Theme Parks.
15. 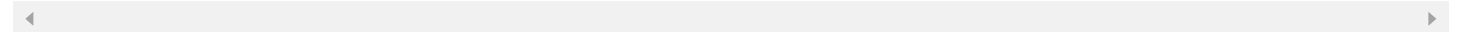
